Heavy Weight Surcharge: for all 20' ctrs ex Asia (excl. Japan & IPBC areas) with cargo weight above 23 MT at USD 200.
North China 20' Container Surcharge: USD 250/20' for origins Dalian, Lianyungang, Qingdao, Tianjin, Xingang, Yantai only.
Suez Canal Transit Surcharge: USD 9.00/teu to all cargo transiting the Suez Canal with origins Australia and Asia excluding Japan
Emergency Risk Surcharge (Gulf of Aden Surcharge): USD 20 / TEU, from January 15th for all origins (Feb 1st ex-Japan&Taiwan) Eff. sailing date.
India Service Tax and Education Cess: Service Tax of 10% to be assessed against all Indian charges (incl. THC, ARB, DOC), Education Cess 3% of the Service Tax. Valid ex- all Indian origins to all ASEU destinations.
Special Equipment Surcharge: USD 200 / TEU - OT / FR
GOH Premium - Single Bar: USD 400 / TEU
GOH Premium - Double Bar System: USD 500 / TEU
